#### **Biography**

Nadin Abdel Razeq, RN, Ph.D., is a Pediatrics and Family Nursing Professor who joined The University of Jordan (JU) School of Nursing in September 2014. Before her position at JU, Dr. Abdel Razeq worked at the School of Nursing, Philadelphia University-Jerash City in Jordan, from 2013 to 2014. Dr. Abdel Razeq is a licensed RN in Jordan and the USA. She has worked in several hospitals in the areas of Neonatal Intensive Care Unit (NICU), Adults Intensive and Cardiac Care, and general Medical/Surgical words where she cared for patients with a variety of health issues, including neonatal intensive caring of preterm neonates, pain management during chronic illnesses, and at end-of-life.

Dr. Abdel Razeq earned her Ph.D. from the University of Nebraska Medical Center in Omaha, NE, USA (2012), focusing on neonatal pain expression. In her Ph.D. dissertation, a mixed methodology using naturalistic observational approaches was applied to describe how painful experiences influence the newborns' sleep-wake states and behavioral and physiologic pain indicators. Dr. Abdel Razeq earned her MSN in Critical Care (Acute) Nursing (2005) from The University of Jordan and her BSN (2003) from Al-Hashemite University, both located in Jordan.

Dr. Abdel Razeq is a licensed Pediatric Advance Life Support (PALS) instructor (2018- date) and a faculty trainer (2022-to date) by the American Heart Association. Dr. Abdel Razeq is also a Newborn Developmental Care Specialist; she became a NIDCAP-certified nurse at Blank's Children Hospital, Camden, NJ, USA, in 2012. She is the first NIDCAP-certified professional in Jordan. As a NIDCAP professional, Dr. Abdel Razeq is qualified to make recommendations to support neonates' development in the NICU based on careful individualized observation and understanding of how neonates communicate their needs to the caregivers. She is also a certified advanced provider in the care of neonates in the STABLE program.

Dr. Abdel Razeq focuses on improving neonates' and children's health care in acute care settings and supporting their parents. This is primarily when the healthcare issues are related to pain assessment and management, family-centered care, ethical decision-making, and end-of-life care. Dr. Abdel Razeq keeps professional development by receiving training and updates on novel teaching methods and evidence-based practices and being a member of several international organizations such as the International Association of Pain and the National Association of Neonatal Nurses. She served as a PI of several nationally and internationally funded projects and advised several graduate students' research projects. She has several scientific papers published in high-impact peer-reviewed Journals.

#### Services

One of my main responsibilities as a faculty member in the nursing university education is to support the mission of the nursing programs at my institution. This required my dedicated service in improving the education process and course management systems. This is mainly achieved through active contributions and ongoing participation in the curriculum development and evaluation committees for

both graduate and postgraduate programs; tasks related to the preparation of self-study documents for national and international (including ACEN) accreditation entities; preparation of benchmark-comparative reports of higher education nursing programs, course development and management, and integrating technology in teaching. I provided consultation and steered external committees related to the development and accreditation of nursing programs, the latest were for two associate nursing degree programs with the Accreditation and Quality Assurance Commission for Higher Education and the National Framework of Neonatal Nursing: Scope of Practice, Standards, and Competencies with the Jordan Nursing Council.

#### **Teaching Philosophy**

My teaching philosophy focuses on applying interactive teaching strategies that concentrate on the students as active participants in the learning process. I believe that interactive teaching strategies are powerful tools for keeping the students motivated to learn, attracted to the learning topic, and developing positive feelings, such as enjoyment and excitement while learning (see examples of teaching strategies). I focus on adopting modern interactive teaching strategies that stimulate rational thinking and clinical reasoning among my students.

I also believe that interactive teaching, when directed towards stimulating higher thinking strategies, is "empowering." For me, student empowerment means that I, as an educator, am a facilitator who assists the students in realizing their inner strengths of thinking creatively about children's and families' health problems and making the students believe in their ability to be changing agents when they graduate and be involved in the practice.

I dedicate my professional development time (for example, through workshops) to building my intellectual capacity and academic teaching methods about innovative nursing education strategies. Specifically, systems incorporating active learning in large classrooms promote students' application of theoretical knowledge to manage complex patient problems and specifically focus on advancing higher-order cognitive skills among nursing graduates.

Therefore, I started to develop innovative and interactive nursing education strategies in my classes to overcome these challenges and, at the same time, help our nursing students achieve the maximum potential of the nursing education process. I always experiment with an approach in my class, seek student feedback, and evaluate the results of my teaching strategies to continually improve my teaching each semester. During my 10 years of post-Ph.D. of academic education experience in Jordan, I have utilized several innovative teaching methods, including project-based learning, real case discussion, critical thinking about teaching subjects or clinical practice, drawing in class for the purpose of learning, reflection on films (for example, Hollywood films), gamification, and role play in education.
